Competitors at the gate on the South dock. If necessary, a new meeting location will be posted on the gate. 12:00 Warning signal for the first races, additional races to follow **Subsequent Saturdays**; **8/10**, **8/24**, **9/14**, **2019**

12:00 Warning signal for the first races, additional races to follow immediately.

All Sundays; 7/27, 8/11, 8/25, 9/15, 2019

11:00 Warning signal for the first race, additional races to follow immediately. **Cancellation of Races**. At least 3 competitors are required for races to be conducted on any given day. If less than 3 competitors are in the starting area at the scheduled first warning time, all races for that day will be cancelled and not included in series scoring. This requirement may be waived to two boats at the sole discretion of the RC.

2. Rules:

This Regatta will be governed by the 'rules' as defined in The Racing Rules of Sailing, 2017-2020.

3. Eligibility and Entry:

The event is open to all PHRF, One design, Multi-Hull and Portsmouth boats whose skipper checks in on the water with the Race Committee. Boats racing in the PHRF fleet shall have a current PHRF certificate issued by the SAIL PHRF committee. Otherwise, a non-negotiable PHRF rating will be assigned by the Race Committee. Boats racing One Design shall comply with their One Design Class Rules. Portsmouth boats shall comply with all Portsmouth rules.

4. Fees

The Carter Regatta is conducted as a free community service. There is no entry fee. Larimer County Park passes for boats or vehicles will be available at the Marina or park entry stations.

5. Measurement

Measurement shall be governed by the individual class associations. PHRF fleet boats must have a PHRF certificate issued by Rocky Mountain S.A.I.L. or in the absence of a valid PHRF Certificate, you may accept a non-negotiable PHRF rating issued by the Race Committee.

6. Sailing Instructions:

Sailing Instructions: (SI's) will be available at the Preliminary Skippers Meeting/Check-in, and will be posted on the CLSC website

7. Regatta Site:

The regatta site will be at the North Pines Area of Carter Lake, Larimer County Recreation Area, west of Berthoud, Colorado.

8. Accommodations:

Some moorings or slips may be available through the Carter Lake Marina. You can contact the Marina at 970-667-1062.

Camping: There are hotels, motels and B&B's in nearby Berthoud and Loveland. North Shore RV Campground and Store is located within walking distance from the CLSC docks and can be reached at: 970-663-6200. Larimer County has both RV and tent sites at Carter Lake: LarimerCamping.com. North Pines and Eagle Campgrounds are the closest to the CLSC docks. Larimer Parks Camping books out far in advance, if you are thinking of attending, please book early. There will be no camping available at the clubhouse.

9. Racing Area and Courses:

Racing area will be shown on the Carter Lake Sailing Club Race Course Chart available online. Inflated marks may be used by RC at their discretion.

10. Trophies

CLSC members are eligible for awards for the Early Season Series Regatta. Non CLSC members are ineligible for awards, but will be scored and the scores posted on the SailCarter.org website.
